### Guam Musicians and Runners Partner with Bank of Guam Raising Over \$8,400 for Soudelor

August 24, 2015 – Hagatna, Guam. During the week of August 17, 2015, local musicians performing at Guam's The Venue, The Joint and Club Icon Clubs raised \$6,200 and partnered with Bank of Guam to directly benefit Saipan victims of Typhoon Soudelor. Led by Chiabe "Bok" Pangelinan, over 30 musicians performed at the three local clubs on August 10, 11 and 15, 2015.

Following this event, the Guam Running Club organized a 5K Run on August 15, 2015 and raised \$2,223, also contributing those funds to the Bank of Guam's Soudelor relief effort.

Funds are still being accepted at the Bank of Guam "Soudelor Aid" account, and will be distributed as follows: 40% to Saipan Red Cross, 40% to Karidat and 20% to Salvation Army.

In addition to the account established for "Soudelor Aid," Bank of Guam® is offering a 90 day loan payment deferment program to its Saipan loan customers in good standing.

Bank of Guam has also extended financial assistance to its employees in Saipan in support of their needs during the recovery period.
